## 1) RANGE RULES

- 1) Always keep your firearm pointed in safe direction.
- 2) Hearing and Eye protection are required on trap, skeet, and five stand fields
- 3) Load your firearm at the firing station only, and unload it before moving to another station.
- 4) Keep the firearm unloaded and the action open when carrying it on club grounds.
- 5) In the event of a misfire, check that the barrel of your firearm is clear before reloading.
- 6) Unload your firearm and keep the muzzle pointed away from the trap house when it is occupied.
- 7) 12 gauge or smaller gauge shotguns only are permitted on the range.
- 8) 1 1/8 oz of lead is the maximum load permitted.
- 9) 7½ shot is maximum size shot permitted. (Acceptable sizes are 7½, 8, 8½, or 9)
- 10) Do not discard misfired shells on the ground.
- 11) Do not shoot birds or targets called by other shooters without their permission.

## 2) AFFIRMATION OF RIGHT TO LAWFULLY POSSESS A FIREARM

I certify that I am not prohibited under any federal, county or state law from possessing a firearm.

## 3) LIABILITY WAIVER (responsibility for accidents and injury)

I understand that guns and shooting are potentially hazardous, and misuse can result in serious injury or death. I agree to assume full responsibility for any and all injuries, losses or damages that may occur to me while on the premises of the Lynden Shotgun Club Range and I agree to accept total responsibility for my actions, and will indemnify and hold Lynden Shotgun Club, its officers and membership harmless, to the maximum extent allowed by law, for costs (including legal fees), injuries, damages, losses, or third party liability for claims asserted against Lynden Shotgun Club arising from my conduct while on the premises of Lynden Shotgun Club Shotgun Range.
